 - *How do you think you can contribute to your group?*
- 2. High School Cert/School current transcripts**
(final transcripts shall be provided by the student upon arrival to Spain)
- 3. At least 1 Recommendation letter from School Teacher**
- 4. CV/Portfolio**
- 5. English Proficiency Certificate:**
(IELTS 6.0 /TOEFL 79+ /Duolingo 100+ /Internal test)
- 6. Additional documentation: Copy of Passport + Passport size photo**

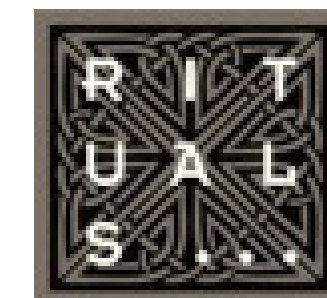
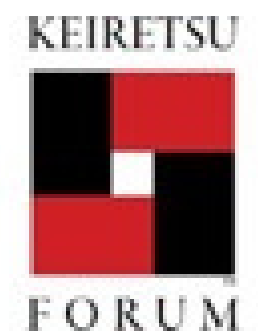

ADMISSION PROCESS

1. STUDENT APPLICATION REQUEST

To start the application process, the Agent should submit the Application Request Form, which can be found on the Agency Portal or can be sent to the Agent via e-mail.

2. ONLINE APPLICATION FORM

The Regional Manager responsible for working with the Agent sends the link to the online application form. The student or authorized agent submits the application.

3. SIGNING THE TERMS & CONDITIONS

Students should carefully read and sign the GBSB Global Terms & Conditions. The Agent agrees to review the Terms & Conditions documents, including the Payment Policy, Refund Policy, Withdrawal Policy, Campus Change Policy, and Intake Postponement Policy, and make sure that the student is aware of all policies and conditions.

4. ENTRY INTERVIEW WITH THE REGIONAL MANAGER

Interviews are conducted via phone, MS Teams, or Zoom and typically last 20-30 minutes. The interview aims to cover the following aspects:

- Introduction;
- Why GBSB Global? Why a chosen programme of study;

- Previous studies and academic achievements;
- Previous professional, internship, volunteering experience (graduate students);
- Hobbies and interests;
- Aspirations and future plans;
- Intake, year and campus of interest;
- Any questions about the programme and the school;
- Outline of the programme entry requirements and documents to submit.

5. NOTIFICATION OF THE ADMISSION DECISION AND RESERVATION OF STUDY PLACE:

- The Regional Manager contacts the agent via e-mail to notify them of the admission decision;
- The Regional Manager sends the Acceptance Letter and the Tuition Payment Plan with the approved installment option;
- The Agent is required to inform the student of the Admissions Committee's decision and to notify the Regional Manager of the student's decision;
- Once the tuition payment is received, the Admissions Support Manager begins communicating directly with the student. The student will receive all welcome information including visa related documents if a non-EU student.
